Physical Access



Venue

Saddlers' Hall was built in 1822 in the neoclassical period style, and as such accessible features have been retrofitted. The main entrance to the venue is reached via a cobbled courtyard, and accessed via steps or a lift from street level. The Great Hall is on the first floor and can be reached via the main staircase, or lift. Accessible toilets are located on the ground floor next to the cloakroom. RDA and venue staff will be on hand to assist and direct throughout.

Travelling by public transport

The closest underground station is:

St Paul's, which is a 2-minute walk from the venue (0.2miles)

Bank is a 4-minute walk and wheelchair accessible (0.5 miles)

Mansion House is a 4-minute walk (0.5 miles)

The closest overground station is:

City Thameslink, which is a 4-minute walk and is wheelchair accessible (0.6 miles)

Blackfriars Station is a 7-minute walk and is wheelchair accessible (1 mile)

Cannon Street Station is 5-minute walk and is wheelchair accessible (0.7 miles)

Quiet Spaces

Communication Accessibility



British Sign Language (BSL) Interpreters

There will be BSL interpreters present throughout the day. Please let us know if you require this service so we can reserve a space at the front, where the signers will be located, or so you can lip-read the speakers.

Language

The meeting, talks and any videos shown will all be conducted in English.

All speakers will be wearing microphones and will be briefed on best practice, including avoiding the use of abbreviations or shorthand in their addresses where possible.

Visual Accessibility



Local crossings have textured paving.

There are no full glass doors, but there are large windows throughout the venue.

The lifts have textured buttons and there will be staff throughout the venue to offer assistance.

Any videos used will have subtitles throughout.

The venue has good lighting throughout.

There will be additional screens to ensure a clear view of content throughout the day.

There will be clear signage of toilets, entrance and exit.

Venue staff will respond in any emergency and are fully trained in supporting disabled people as needed.

Although, at her own admission, this is not something she excelled at.

Ellie brings 30 years of working and leading in the Voluntary Sector and is currently the Chief Executive of NHS Charities Together, the national charity caring for the NHS and membership body to the UK's NHS charities. She was at the helm of the charity's Covid-19 urgent appeal in 2020, which raised £162m to support NHS staff, volunteers, and patients impacted by the pandemic.

Ellie was awarded the Outstanding Individual Achievement Award by the Charity Times in 2021, the Outstanding Achievement Award 2021 by APM, Charity Times most pioneering CEO's, the Health Service Journal's top 100 CEO's, and an OBE by Her Majesty The Queen for her contribution to the NHS during Covid.

Rosie Scott-Ward

Rosie brings over 25 years of experience in education and the equine world to the RDA. Her passion for horses started when she began riding at age 7 at an RDA centre in Cumbria, despite coming from a non-horsey family. This love for horses led her to compete in British Eventing while earning a degree in Equine Science, followed by a Master's in Equine Science. Her research focused on how water-based exercises affect horse movement.

In 2002, Rosie joined Hartpury and has since held various academic and commercial roles, including Equine Director. She has strong experience in managing change, having led Hartpury's transition to University status. As Deputy Vice Chancellor, she is responsible for overseeing all academic work and the equine activities at Hartpury. Recently, Rosie chaired the Hartpury Horse Advisory Board, which developed the Hartpury Happy Horse Principles and the Hartpury Horse Charter, promoting evidence-based best practices for horse care.

Rosie is a founding director of the Equine Assisted Services Partnership and a trustee of Community Action Nepal. She also serves as the Executive Event Director of the Hartpury International Horse Trials.
