## The Business of the Meeting

The purpose of the formal AGM is to present the annual report for the previous year to end March 2024, appoint auditors for the year ahead, elect board directors and vote on any other important matters. With that in mind, members will be asked to:

- Receive the Trustees' report and the audited accounts
- Re-appoint our auditors, Sayer Vincent LLP
- Elect one new Trustee under article 35.4
- Re-appoint one Trustee due for re-election under article 35.4
- Note the appointment of two new Trustees appointed by the Board under article 35.5

These matters will be proposed as ordinary resolutions, requiring a simple majority of Member Groups to vote in favour of the resolutions to pass. No special resolutions are proposed at the 2024 AGM

## **Proposed Trustees and Biographies**

New Trustees are proposed following a skills-based, open recruitment process and we were delighted by the strength of the field of applicants. As a result, there are a total of three new proposed trustees, each of whom will bring valuable expertise and experience to RDA.

This year, one person is presented to the membership for election as a member of the Board of Directors ("**Trustees**") under article 35.4 of the Company's articles of association (the "Articles"):

The Board also proposes to appoint two new members of the Board of Directors ("**Trustees**") in accordance with article 35.5 of the Articles and asks members to note those appointments:

In addition, the Board proposes to present Lindsay Correa for re-election by the membership for her final three-year term of office under article 35.4 of the Articles.

Note, you may also vote online and still join us at the meeting in person, however you will not be able to vote again if you have previously cast your vote electronically.

Space is limited and we are required to give preference to duly authorised representatives of Member Groups and appointed proxies, so please do confirm your attendance to National Office at your earliest convenience.

## NOTES TO THE NOTICE OF AGM

# Attending the meeting

- A Member Group may send a representative to the AGM. One duly authorised representative may speak and vote at the meeting on behalf of a Member Group. Group representatives are encouraged to confirm attendance via RDA's voting platform, managed by UK Engage.
  - Notifications of a member group's authorised representative will be processed in accordance with Article 12 of the memorandum and articles of association. To help us ensure that your decision is received and processed accurately, please submit a notification of your attendance as soon as possible. We encourage you to do so by or before 11am on Thursday 31 October 2024.
- 2 Non-members may attend the AGM (subject to availability). Non-members should contact <a href="mailto:agm@rda.org.uk">agm@rda.org.uk</a> to confirm their attendance by 11 am Thursday 31 October 2024

# **Appointment of proxies**

- 3 Each member of the Company is entitled to appoint a proxy or proxies to exercise all or any of its rights to attend, speak and vote at a general meeting of the Company.
- As an alternative to sending a duly authorised representative, a Member Group may appoint someone, usually their Regional Chair (or a member of their Regional Committee) as a proxy to exercise all or any of that Member Group's rights to attend, speak and vote at the meeting.
- A vote withheld is not a vote in law, which means the vote will not be counted in the votes for and against the resolution. If you do not give your proxy an indication of how to vote on any resolution, your proxy will vote or abstain from voting at their discretion.
- Voting is managed through RDA's voting platform, managed by UK Engage. For a proxy vote to be effective the form of proxy, the instrument appointing a proxy and any authority under which it is executed must be completed online not later than 11 am Thursday 31 October 2024. Paper proxy forms can be requested in exceptional circumstances. We encourage all members to vote online as that helps ensure all votes are accurately recorded.
- Completion and return of the form of proxy will not prevent a Member Group's duly authorised representative from attending and voting in person at the meeting, subject to registering the name of the representative via RDA's voting platform, managed by UK Engage by 11 am Thursday 31 October 2024.

# Voting by attendance

If your Member Group will be sending a representative to the AGM, you are encouraged to register your representative on the UK Engage Voting Platform. The groups representative will be presented with a voting card at the registration desk.

# **Voting by proxy**

If your Member Group will be voting by proxy, please register your vote online, indicating how you wish your proxy to vote, at your earliest convenience and not later than 11 am Thursday 31 October 2024. All members are required and encouraged to vote through RDA's voting platform, managed by UK Engage. Proxy Forms can be requested in exceptional circumstances
